All horses shipped to Hawthorne Race Course whether interstate or intrastate, must be accompanied by a health certificate dated no more than 10 days prior to arrival. Health certificates (Including date of latest EHV-1 vaccination) and a copy of the current negative coggins test must be presented at the stable gate upon arrival or horses will not be allowed to enter the grounds. **All horses must have Proof of EHV-1 vaccination in the last 180 days but no closer than 14 days as well as current Coggins test on file in the racing office upon entering the grounds.**

The undersigned represents that he and all persons for he is acting have read and are familiar with the Rules of racing and regulations of the Illinois Racing Board, the race meeting conditions and Rules of Hawthorne Race Course and agrees to be bound and comply with the same, and agrees that all animals shall be subject to the same, and further agrees to be bound by the acts and decisions of the Race Officials and to all terms and conditions of any Contract with the Chicago Division of the I.T.H.A. and this application. All trainers, prior to having horses stabled at Hawthorne Race Course, must have Workmen's Compensation Insurance as required by the Illinois Racing Board.

**HORSES NOT ALLOWED TO BED ON SHAVINGS**

**Absolutely no dogs or poultry allowed on the grounds!**

The undersigned in consideration of the allotment of stalls does hereby waive and release any and all liability of Hawthorne Race Course for any loss, damage or injury to any personnel or horse or other personal property of the undersigned on Hawthorne's premises, except if caused by the negligence of Hawthorne or their Officers, Agents or Employees and does hereby indemnify Hawthorne for any fees, cost, or damages caused by any horse or personnel of the undersigned while on said premises.

**Ban on Horse Slaughter.** Any owners or trainers stabled at HAWTHORNE found to have directly or indirectly sold a horse for slaughter will have his or her stalls permanently revoked from HAWTHORNE. HAWTHORNE requires its horsemen to conduct due diligence on those buying horses and encourages them to support rescue and adoption efforts and to find humane ways of dealing with horses unable to continue racing.

## IMPORTANT READ CAREFULLY

The undersigned hereby states that he/she is either the owner or has full authority from the owner or owners of all horses listed in the instrument to sign same and hereby makes application for stall space and use of the facilities at HAWTHORNE RACE COURSE for the 2023 race meet for all said horses, and said Applicant hereby agrees in consideration of the acceptance of this Application and Agreement and the use of said stall space and facilities, on behalf of the owner or owners of all horses listed herein, to the following provisions and conditions:

1. This instrument shall be binding upon the owners and trainer of all horses listed herein and all employees, agents, servants and members of the families thereof, and in every place where the term "Applicant" is used in this entire instrument it shall include and cover all such persons in the same manner as if listed fully at each such place where said term "Applicant" appears.
2. It is agreed that Owners of HAWTHORNE RACE COURSE nor any of their Officers or agents shall be in any way liable for any loss, damage, death or injury of any kind to any person, animal or property arising out of or connected with the presence on or use of the HAWTHORNE RACE COURSE premises by said Applicant and all employees, Agents, Jockeys, members of the families, property and animals of said Applicant, whether such injury, loss, death or damage is claimed to be caused by the condition of said premises or any act or negligence or omissions to act of said owner of the premises, or of their agents or servants or any other cause, and the undersigned Applicant hereby specifically assumes all such risks fully and completely.
3. The undersigned Applicant hereby agrees to indemnify and save harmless said owner of HAWTHORNE RACE COURSE and their respective Officers, employees and agents from any and all liabilities, claims and demands for damages, injuries, deaths or losses or costs or expenses of any kind resulting from or arising out of or claimed to result from or arise out of the presence on or use of said premises at HAWTHORNE RACE COURSE by said Applicant and all employees, agents, Jockeys, members of the families, property and animals of Applicant and Applicant agrees to defend any claim or suit which may arise from the foregoing and to pay all attorney's fees and costs thereof.
4. Cooking shall not be permitted in the stable and paddock areas. Electrical or mechanical devices such as refrigerators, walkers, etc., need prior approval.
5. HAWTHORNE RACE COURSE reserves the right to decline stall space and to have stalls vacated 24 hours after notice to vacate has been received.
6. All owners, trainers, Jockeys and caretakers are subject to the Illinois statues, Rules and Regulations of the Illinois Racing Board, and HAWTHORNE RACE COURSE.
7. All owners, Jockeys, trainers, agents, grooms and stable help must be licensed by the Illinois Racing Board.
8. HAWTHORNE RACE COURSE reserve the right to refuse admittance or to reject anyone considered undesirable in the best interest of racing
9. Copies of Workmen's Compensation Insurance Policies from Owners or Trainers must be filed with State Steward's Office to race at HAWTHORNE RACE COURSE.
10. "Applicant on his own behalf and as agent for any horse owner receiving stall space or upon entering horses for racing purposes, agrees that he and his principals shall be bound by all the terms and conditions of any written agreement between the track and the ITHA, including, but not limited to the distribution of purse money to said Association for Insurance, Welfare, Administration or any other contractual purposes; and, further, the applicant or his principals agree to said contractual agreement although they may not be members of the Association and may not benefit directly or indirectly."
11. Ban on Horse Slaughter. Any horsemen stabled at Hawthorne found to have directly sent a horse for slaughter may be subject to the following: loss of stalls at Hawthorne, loss of ability to race at Hawthorne, fine and/or license revocation. Hawthorne requires horsemen to conduct due diligence on those buying horses and encourages them to support horse rescue and adoption efforts. Hawthorne asks that horsemen contact Galloping Out or look to find humane ways of dealing with horses unable to continue racing.
12. Upon vacating stalls, horsemen must remove any bedding in stalls and place in aisleway. Failure to do so will result in \$250 fine.
13. Smoking is not permitted in the stable area.
14. Trainers are responsible for informing the security office of any change in their staff.
15. All hoses should be equipped with automatic shut off nozzles.
16. **No firearms allowed in the stable area.**
17. **HORSES WILL NOT BE ALLOWED TO BED ON SHAVINGS AT HAWTHORNE RACE COURSE.** Horse Manure must be deposited in the bins provided and areas surrounding must be kept clean.
18. **No Dogs or Poultry are allowed on the grounds.**
